## **Ed Dressler Recognition**

The funeral procession will travel on the Little Miami Scenic Trail from Yellow Springs to Xenia. The Little Miami Scenic Trail in Greene County will be signed as the "Ed Dressler Memorial Trail"

### **Old Business:**

Special Projects Manager Charles Frazier updated the Board on the current special projects within the park system.

- 1. Ohio Erie Trail Resurfacing:
  - We have gotten approval from MVRPC to move our project up from SFY 2025 to SFY 2023. It is in a reservoir for SFY 2022 should funding become available for the project. The plans are at ODOT for final approval.
- 2. Pearl's Fen Waterford Landing Addition:
  - We have closed on the 7.4 acres.
- 3. PDAC Award:
  - Applied in 2019, rolled the application over in 2020 and was awarded in 2021.
    Hobson Freedom Park and Karohl Park will receive CXT restroom facilities this year. Hobson will be a full flush unit with water and sewer.
- **4.** ODNR Paddling Grant:
  - We are submitting a grant application for improvements to Constitution Park's access to the Little Miami River.
