**Projects:**

Mr. Inman updated the board on the current special projects within the park system.

1. Little Miami Scenic Trail: Ditch clean was completed from Hedges Rd. towards Xenia Station.
2. Sealcoating of Trails Completed: All of Little Miami Scenic Trail, asphalt section of Wright Brothers Huffman Prairie Trail, Xenia-Jamestown Connector – from Frank Seaman Spur to St. Rt. 72.
3. Caesar Ford Campground: Sidewalk to playground is completed.
